- Approved applicants will be allotted organic lease on the first available A-Period in which allocation has not been set.
- Organic lease is issued annually for a maximum of 7 years to approved applicants.
- Organic lease will be allotted between March 1st and the last day of February each year. Please note if these dates fall in between the start or end date of the national A-Period the closest start and end A-Periods will be used provided it does not exceed 56 weeks in total.
- Organic lease price is effective between March 1st and the last day of February each year. Please note if these dates fall in between the start or end of the national A-Period the closet start and end A-Periods will be used provided it does not exceed 56 weeks in total.
