Each Infected Premise (IP) has been placed under quarantine. The Canadian Food Inspection Agency (CFIA) has established a Primary Control Zone (PCZ) around the infected premises, to restrict movement in the area. There are currently 10 active Primary Control Zones (PCZ) in AB. The APIEMT is working closely with the CFIA and Alberta Agriculture, Forestry and Rural Economic Development, to expedite the investigation of suspected cases and mitigate the potential risk of further spread of AI in Alberta. At this time the cause of the confirmed cases of AI is unknown, but is believed to be linked to migratory birds, as has been the case recently elsewhere in both Canada and the United States.

Alberta poultry farmers and industry partners are implementing enhanced biosecurity measures to protect their flocks and safeguard the supply of fresh, local eggs and poultry products. The APIEMT will share additional details as they become available.
