Notice: Reallocation of Quota Policy and Sales Agreement Revisions

Please note: Effective immediately, Final payment for quota purchases is to be made in full in the seller's final production cycle that the quota units are fully utilized. The Seller will disengage any further production of the sold quota units on the date those quota units are assigned to the Buyer. The Buyer then has the option to lease out the newly acquired quota units back to the Seller or other interested producers, should the Buyer not be poised to assume production on the effective start date provided by the Board.

Alberta Chicken Producers' Plan Regulation Amendments Receive Approval

Building from the strong support and mandate received from producers at our 2021 AGM for the development of bylaws for ACP, our team worked with the staff at Alberta Agricultural Products Marketing Council on drafting bylaws for ACP, building from those developed by other similar commodities. This work continued over the next several months and, once finalized, producers were consulted on the proposed bylaws and corresponding changes to our Plan Regulation.

Note: the Board did not make any changes at this time to ACP's internal governance operations. What was contained in the draft bylaws had been directly removed from the Plan Regulation with no changes or additions.

Why Create Bylaws and Amend the Plan Regulation?

- All provisions in ACP's Plan Regulation regarding ACP's internal governance operations need to be approved by producers, the Board, Marketing Council, the Minister and, finally, the Alberta Government's Cabinet. *This bylaw structure enables ACP to modify the internal governance provisions that once existed in Plan Regulations, without involving government decision-makers like the Minister of Agriculture and Irrigation or Cabinet who are not directly involved in our industry, while maintaining the process of seeking approval from Producers and Marketing Council.*
- Bylaws enable the internal governance-related operations, such as director terms of office, producer eligibility and rights, voting and election processes, and duties of the returning officer, to be amended in a timely and flexible manner while continuing to follow the process of receiving the approval of producers, the Board, and Marketing Council.
- It upholds the Requirements in ACP's Marketing Regulation as licensing, programs and policies such as our On-Farm Food Safety and Animal Care Programs, service charges, penalties, and other administrative and technical matters would not be moved into bylaws.

- Bylaws are enforceable. Decisions made or actions under the bylaws can be challenged through the Marketing of Agricultural Products Act's (MAPA) review and appeal process.
- The movement of these provisions from ACP's Plan Regulation into Bylaws contributes to the Alberta government's commitment to reduce regulatory burden on Albertans.

Following consultation with producers, the Bylaws and proposed Plan Regulation amendments were presented to Marketing Council and then moved to the Minister for approval of the Plan Regulation amendments. We have received notice from Marketing Council that the amendments to our Plan Regulation were approved to allow us to maintain ACP Bylaws, part of the Government of Alberta's Red Tape Reduction Amendment Act. This is great news as it will allow ACP more flexibility and a streamlined process in making changes as amendments to bylaws require approval from Marketing Council and don't have to progress to the Ministry. **Please note that producer consultation will continue to be conducted prior to any bylaw amendments.**

Underused Housing Tax - Important information for Farmers

The Underused Housing Tax (UHT) Act implements an annual 1% tax on the value of vacant and underused residential properties directly or indirectly owned by those who are not permanent residents or Canadian citizens. It became effective Jan. 1, 2022, and the first tax return for year-end Dec. 31, 2022, is due at the end of April 2023.

CFA would like to urge its members to distribute the following information to its members, as all Canadian farm corporations, farm partnerships or trusts that own residential property will HAVE to file a UHT this year, even if they are exempt from paying the tax. The application of penalties and interest under the UHTA for the 2022 calendar year will be waived for any late-filed underused housing tax (UHT) return and for any late-paid UHT payable, provided the **return is filed or the UHT is paid by October 31, 2023.**

This transitional relief means that although the deadline for filing the UHT return and paying the UHT payable is still April 30, 2023, no penalties or interest will be applied for UHT returns and payments that the

CFA is seeking an exemption to the UHT for agricultural businesses in the future to reduce the administrative burden of this tax. While CFA is seeking long-term solutions for this issue, our efforts will most likely not impact the current tax year, so we still encourage producers follow the guidance laid out below.

How does the UHT impact your farming operation?

If you operate your farm through a Canadian corporation or Canadian partnership and it owns a residential property, you will be required to file a UHT return even if no UHT is owed due to applicable exemptions noted below. If you do not file, the late filing penalty will apply.

Let's look at the example of a Canadian corporation carrying a cash crop operation. The corporation is 100% owned by Canadian citizens and possesses several residential homes on its farms. This corporation is required to file a UHT return. It would be exempt from the UHT as a Specified Canadian Corporation, but the UHT return must still be filed to claim the exemption. It could be subject to a \$10,000 penalty if it does not file a UHT return on time. This penalty would apply for each year a UHT return is required and not filed by the April 30 deadline.

How much is the UHT?

The UHT on vacant or underused residential property is 1% of the home's taxable value or 1% of its most recent sale price, whichever is greater. Owners can also file an election between Jan. 1 and April 30 of the following calendar year to use the property's fair market value (FMV) to determine the owing UHT and if they can obtain an appraisal. If two or more individuals hold title to a property, each owner will be responsible for the UHT based on their ownership interest.

What are the UHT filing requirements and penalties?

Failure to file a UHT return by April 30 of the following year, when required, could result in a penalty of at least \$5,000 for individuals and \$10,000 for other entities, such as Canadian corporations, partnerships, and trusts.

If an owner qualifies for an exemption but is not an excluded owner, the UHT return still must be filed, even if an exemption applies and no UHT is owed. The penalty for late filing will apply.

What should farm owners do next?

The UHT has received little attention since it became law, as many Canadians believe it simply does not apply to them—but the law affects a broad range of property owners. Countless numbers of farm corporations and farm partnerships across this country will have an obligation to file a UHT return, even if they owe no UHT. Non-filing can result in substantial financial penalties.
