\*\* When the difference between the Alberta and Ontario feed costs per tonne is within or equal to the \$5/tonne bandwidth, the feed cost component in the Alberta live price is calculated as follows:  
= Ontario feed \$/tonne / 1000 X AB Feed Conversion Ratio

When the difference between the Alberta and Ontario feed costs per tonne is greater than +/- \$5, the feed cost component in the Alberta live price is calculated as follows:

*If Alberta – Ontario feed \$/tonne is a greater difference than +\$5/tonne:*

= (Alberta feed \$/tonne - \$5/tonne)/1000 X AB Feed Conversion Ratio

*If Alberta – Ontario feed \$/tonne is a greater difference than -\$5/tonne:*

= (Alberta feed \$/tonne + \$5/tonne)/1000 X AB Feed Conversion Ratio

\*\*\* The Ontario broiler chick cost/kg and Ontario Producer Margin, which are updated and published periodically on the Chicken Farmers of Ontario's website, are utilized in setting the Alberta minimum live price. The Ontario specific costs of Modular Loading, Avian Influenza Disease Insurance, and CFC Levy Accrual Recovery for Ontario (concluding at the end of A-181) are not included in the Alberta Minimum Live Price.
