$$= \text{ON feed } \$/\text{tonne} / 1000 \times \text{AB Feed Conversion Ratio}$$

When the difference between the AB and ON feed costs per tonne is greater than +/- \$5/tonne the feed component in the AB Live Price is calculated as follows:

If AB – ON feed \$/tonne is a greater difference than +\$5/tonne:

$$= (\text{AB feed } \$/\text{tonne} - \$5/\text{tonne}) / 1000 \times \text{AB Feed Conversion Ratio}$$

If AB – ON feed \$/tonne is a greater difference than -\$5/tonne:

$$= (\text{AB feed } \$/\text{tonne} + \$5/\text{tonne}) / 1000 \times \text{AB Feed Conversion Ratio}$$

*** The Ontario broiler chick cost/kg and Ontario Producer Margin (which are updated and published periodically on the Chicken Farmers of Ontario's website: <https://www.ontariochicken.ca/en/farmer-dashboard/resources/fgmlp/>), are utilized in setting the AB Minimum Live Price. Effective A-200 ON AI Insurance Premium increased from \$0.0015 to \$0.0025=\$0.0010/kg (deduct). Effective A-195 Avian Influenza Disease Insurance of \$0.0015 is included in the Alberta Minimum Live Price and therefore no longer deducted as an ON specific cost. The Ontario Farm-Gate Minimum Live Price is based on the Bird Weight category of over 2.15 kgs to 2.45 kgs.
