The Alberta Chicken Producers Marketing Regulation States:

- 20(1) Any person who holds a financial interest by means of a mortgage registered under the *Land Titles Act* in respect of the production facilities and premises to which an authorized quota has been allocated may register that interest with the Board in a manner that is satisfactory to the Board.
- (2) If a mortgagee registers an interest with the Board under subsection (1), that mortgagee must at the same time also register with the Board a written acknowledgement by the authorized producer of the mortgagee's financial interest in the production facilities and premises.
- (3) If an interest is registered under subsection (1), the Board must (a) immediately notify the authorized producer who has been allocated the authorized quota of the registration, and (b) notify the mortgagee of any application to reallocate all or any part of the authorized quota to which the registration applies.
- (4) The Board shall not approve the reallocation of any authorized quota in respect of which an interest is registered under subsection (1) unless the mortgagee has given written consent to the reallocation.
- (5) Only one financial interest may be registered in respect of an authorized quota.
